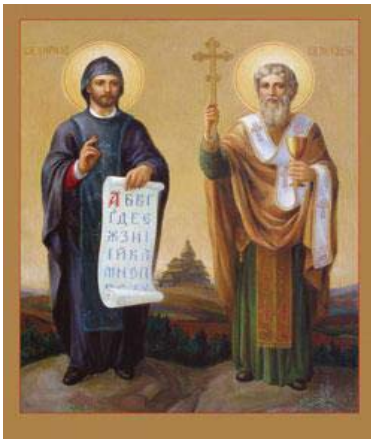

SEVENTH SUNDAY IN ORDINARY TIME

“Jesus said to his disciples: ‘To you who hear I say, love your enemies, do good to those who hate you, bless those who curse you, pray for those who mistreat you. To the person who strikes you on the cheek, offer the other as well, and from the person who takes your cloak, do not withhold your tunic. Give to everyone who asks of you, and from the one who takes what is yours do not demand it back. Do to others as you would have them do to you.’”

We are familiar with the ‘golden rule’. And it seems quite logical. BUT are you sure the Christian life is easy? The teaching of Jesus tells us otherwise. It is easy to fall, but when I listen carefully to the teaching today, I ask the grace I need, and take positive steps to put His words into practice. With Paul I can say ‘I can do all things in him who strengthens me.’
