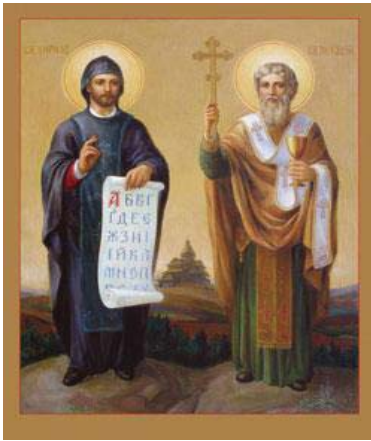

SACRAMENT OF BAPTISM

Reservations for the class should be made by calling the Parish Office at least 2 weeks in advance of the Baptism. Godparents must be confirmed Catholics. One non-Catholic may be accepted as a Christian witness.

Arrangements should be made at least one year in advance of the marriage date. Engaged couples should make an appointment to meet with the Pastor in the office to determine a date, discuss all the requirements for the marriage, and have it officially registered.

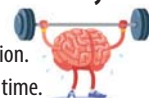
